No Exceptions will be made. You may borrow an animal that was shown during the Junior Fair or animals may be brought to the Rec. Park the Sunday morning of the Little Britches show. All animals will be released at the same time as other livestock entries (Sunday at 5:00 pm). After a short walk around the show ring and an interview, all young showmen will receive participant ribbons and donated prizes. There is no Entry Fee. We encourage moms and dads, brothers, sisters, grandmas and grandpas, aunts, uncles and friends to bring their cameras!
