Pandemic or not, Extension's purpose is to teach, learn, lead and serve, connecting people with the University of Wisconsin, and engaging with them in transforming lives and communities. I think you'll see the meaningful and transformative work for lives and communities here in Dunn, in Agriculture, Horticulture, Health and Well-Being, Human Development and Relationships, Positive Youth Development, and Community Development. One day in

particular stood out for me, a meeting we held in September with our staff from three counties and the Extension oversight committees from Chippewa, Dunn, and Eau Claire

Counties. Our team of educators shared out on these key themes:

- Teaching and Capacity Building at Farm Technology Days
- Growing Food Security: Local Farmers Market Match Program

• Supporting Thriving, Just, and Resilient Place-Based Food Systems.

Extension's educational capacity is multiplied through the power of volunteers, who give thousands of hours of education to the county.

Beyond our local Extension programming, we have been able to partner with professional development offered at no additional cost to the county, such as Civility and Diversity in Local Government. Out of 65 participants statewide, we had 55 from Chippewa, Dunn, & Eau Claire Counties.

Last and not least, we could not be successful in Dunn County without the valued support from the county, community partnerships, and most importantly, the people who live here.

The Wisconsin Farm Technology Days is the largest agricultural show in Wisconsin and one of the largest in the nation. The threeday outdoor event showcases the latest improvements in production agriculture, including many practical applications of recent research findings and technological developments. Each year, it is held in a different Wisconsin county - on a different host family farm. The 2021 event was held July 20-22 in the Eau Claire area. Jerry Clark, Chippewa County Agriculture Agent, and I cochaired the Extension educational area at the event.

Extension educators from four Agriculture Institute program areas, in addition to the Master Gardener program, collaborated on educational stations for the 2021 Wisconsin Farm Technology Days. The goal of this effort was to increase producer's knowledge of Crops and Soils, Dairy and Livestock, Master Gardener, and Farm Management



program educational initiatives. Examples include cover crop demonstration plots, mitigating dairy cattle heat stress, beef x dairy cross calf care, farm statistics, how much meat to expect from a hog, lamb, and steer, alternative forage crops, weed identification, and more. Program educators staffed each station, along with Master Gardener Volunteers, to answer questions. Extension educator relationships were leveraged to partner with a dairy goat producer to present milking demonstrations, with the goats displayed in an Extension pasture seeding mix demonstration plot. New program area topic hubs were promoted through the use of QR codes and handouts with new website addresses. An estimated 50,000 people attended the three day event.

Tractor Safety

14 youth between the ages of 12 and 18 completed the 2021 Wisconsin Tractor and Machinery Safety Certification Course in Dunn County. This year's program consisted of a mix of virtual instructions (10 hours), self-study (8+ hours), a written exam, and an in-person driving exam. The training program was held June 7-10, 2021. After completion of the in-class and self-study hours, youth were required to pass a written exam and a tractor driving test. Youth participating in the course who passed both of their tests then received their State, and/or Federal tractor safety certifications depending on age.



<u>AgriVision</u>

A podcast series, AgriVision, for farmers and ag professionals, where Extension educators answer Farm Management questions and share knowledge and expertise on how farmers can improve their farm management skills.

A portion of Episode 11 Careers in Agriculture was utilized for a national segment, 'Farm to Fork' with Host Darrell Anderson, that aired on Tuesday, April 12 in 13 states on over 200 stations.

Community Development



Addison Vang Community Development Educator

Community Food Systems, as the focus area, integrate culturally responsive food production, processing, distribution, consumption,



and disposal to enhance the environmental, economic, social, and nutritional health of a particular place. As such, community food systems offer an alternative vision to the dominant food system by shortening the length and increasing the transparency of food supply chains while emphasizing links between food, place, and culture as well as values such as social justice, sustainability, and resilience.

Exploring Capacity to Serve HMoob Farmers is an Extension statewide effort to support HMoob (Hmong) farmers. Wisconsin is home to a significant portion of the HMoob American population and the HMoob language is the 3rd most commonly spoken language in the state. HMoob farmers are critical to Wisconsin farmers markets and community food security since their arrival in the late 1970s. Yet, knowledge of HMoob farmer needs is limited, as is their knowledge of what Extension offers. Efforts to bridge this gap include group discussions and interviews with HMoob farmers, as well as with partner organizations. Extension can improve knowledge, support needs, and find new ways to work with HMoob farmers while strengthening relationships and improving access to Extension programs.

Nonprofit Peer Learning Program is a virtual pilot training and networking educational program that prioritizes peer learning for both new and established nonprofit organizations. Participants share and learn about nonprofit fundraising, sustainability, and program evaluation. The purpose of the program is to increase organizational capacity to address community needs. The program was piloted in Pierce and Dane Counties with future possibilities in other counties as the program and its curriculum is further developed.

Our new Community Development Educator starting in August 2021. Here are a few trainings and programs:

- Provide local support for graduates of the Entrepreneur In Training (EIT) Program
- Food Entrepreneurship Ecosystem Development (FEED) Project Virtual Winter 2022 Workshop Series
- "Civil Leadership for Vibrant Communities" program designed to build civil civic leadership skills and community leadership networks across Wisconsin.



Elevando Wisconsin is a statewide virtual educational leadership program designed to elevate the Latinx communities with leadership skills and build a network of leaders across Wisconsin around culturally relevant topics. The program provides simultaneous English and Spanish interpretation.

Well-experienced interpreters have shared that the program is very unique and powerful. Specifically, the interpreters have lots of experience interpreting for English speakers to present to Spanish speaking audiences and for the audience to just listen and learn. These sessions throughout the program are very interactive, engaging, and recognize the knowledge, skills, and strengths, that both speakers and participants bring to the learning and networking opportunity.

Opportunities for the Future in 2022

A Specialty Crop Block Grant submitted by Chippewa Valley Produce LLC was approved by the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) to support in building capacity of underserved specialty crop growers in Western Wisconsin. The grant will support the development of workshops and tours covering farm business management, best agricultural practices, and farm financial resources. Local organizations, such as the Black and Brown Womyn Power Coalition, Eau **Claire Area Hmong Mutual Assistance** Association, and DATCP, will be supporting and partnering to make this program successful.

The HMong Economic Development Summit is currently being planned for the fall in the City of Eau Claire to highlight, share, learn, and network between HMoob (Hmong) owned businesses. The summit will be a 3-day event with the first 2 being a conference, coinciding with an outdoor community event showcasing minority owned food businesses such as food trucks and crafts, and cultural entertainment with an emphasis on local entrepreneurs. The event provides an opportunity for other HMoob owned businesses and entrepreneurs to interact on a platform specific for them to succeed, share, and network, with a fartherreaching goal of creating thriving BIPOC owned businesses.



FoodWlse



Healthy Choices, Healthy Lives

FoodWIse is federally funded by the Supplemental Nutrition Assistance Program-Education (SNAP-Ed) and the Expanded Food and Nutrition Education Program (EFNEP). We advance healthy eating habits, active lifestyles and healthy community environments for Wisconsin residents with limited incomes through nutrition education at the individual, community and systems levels.

The Challenge

In response to the ongoing challenges in reaching SNAP-Ed audiences with direct education during the pandemic, FoodWIse increased the delivery of indirect education. This included an expanded social media and website presence, local online and print resources, electronic materials and handouts, and pre-recorded videos; all with the overall goal to continue to reach audiences with helpful nutrition information and resources empowering participants to live healthier lives. Dunn County continued to deliver

nutrition education by sharing 1259 indirect educational materials through the use of electronic class materials and newsletters; hard copy handouts to students, parents, and

participants; videos, social media, and nutrition educational reinforcement items.



Community IMPACTS



- Created three cooking videos utilizing Stepping Stones Food Pantry items to help participants utilize available foods. Videos were available to over 1500 families.
- Collaborated with multiple community coalitions and agencies to create and implement the Summer Activity Passport in the Chippewa Valley. This program supported chronic disease prevention and encouraged families to stay active locally.
- Youth lessons were provided via in-person, virtually, and pre-recorded videos. Parents/guardians received multiple print resources and electronic newsletters about our lessons and included nutritional information.
- Provided WIC families with virtual lessons and guidance at Farmers Markets. We were able to provide Walmart and Kwik Trip gift card incentives as part of a national Cooking Matters program. Participants were able to then purchase recipe items.
- The FoodShare program at the farmers market was expanded with the new Market Match to increase access to produce. FoodShare sales more than quadrupled!

ACHIEVING MORE TOGETHER



UW-Madison Division of Extension works alongside the people of Wisconsin to deliver practical educational programs where people live and work – on the farm, in schools and throughout urban and rural communities. In Dunn County, FoodWIse partners with River Heights Elementary School, Menomonie and Colfax Head Start Centers, WIC, Workforce Resource, Boys and Girls Club, Hmong Friendship Center, ADRC Congregate Meal Sites, Shirley Doane Senior Center, and Stepping Stones Food Pantry to help make the healthy choice the easy choice in our communities.

Whether virtual or in-person, FoodWIse helps youth to understand the importance of nutrition and make better choices when eating.

Parents and Teachers agree that FoodWIse classes work!

- 80% of parents responding to evaluation surveys agreed that their children had been eating more vegetables, were more willing to wash hands, and consumed less sugary drinks following lessons.
- "My kids...came home in the afternoon after the sessions and excitedly told me about the day's topics. I was excited to have some "back-up" from other adults who preach the same things we do in our household: eat healthy and wellbalanced meals and move your body. Thank you for this program."
- Teachers observed students eating more vegetables, fruit, and bringing better snacks from home.

New in 2021! FoodShare participants can double bucks at Farmers Market with Market Match program.

Through a FoodWIse led collaboration with WestCAP, Health Dunn Right Coalition, and funding from The Community Foundation, the first Market Match program started in May, 2021.

For each FoodShare (FS) purchase up to \$10, participants were given a match number of tokens. Word spread and the response was immediate.

Horticulture Education

As the Horticulture Educator in Chippewa, Dunn and Eau Claire counties, I am well-positioned to support the use of environmentally-sound horticultural practices by educating the public directly and through local volunteers in the Master Gardener Program. Through education and outreach, we connect residents to a wide range of university-based resources and diagnostic services such as soil testing, general plant disease diagnostics, general insect identification and turf grass diagnostics. Horticulture programming can also have a positive impact on food security and personal and community well-being

The Need

Wisconsin faces many environmental challenges such as pollinator decline, climate change and environmental pollution due to over use of horticulture chemicals in urban and suburban environments. Teaching horticultural best practices can play an important role in helping address these challenges at a local level. For example, our outreach on proper plant selection can reduce invasive plant species and provide habitat for native pollinators. Education on proper pest management techniques can lead to less pesticide use leading to reduced likelihood for environmental pollution.





Make a Difference

Horticultural Inquiries

As a county-based educator, I answer horticulture inquiries from Area 6 following an Integrated Pest Management (IPM) approach, which emphasizes actions that reduce the impact of pests while minimizing negative effects on the environment. In 2021, I had over 300 horticulture inquiry contacts area wide that included inquiries coming to the Extension offices and during programs. In Dunn County, horticulture questions spanned a wide range with questions on trees, landscaping and plant ID the most common.

Despite this, they continued to fill their volunteer commitments and rose to the challenge to educate through virtual platforms as reflected in the above effort data. (Horticulture

Teach Best Horticultural Practices

A key strategy of Extension programming is live presentations whether in-person or online (which allows for increased access to Extension expertise and resources). Examples of 2021 programming efforts include my work on the Foundations in Horticulture Steering Committee. Foundation in Horticulture is a self-paced, statewide, online course that teaches research-based methods to grow plants and manage pests. In 2021, the course was piloted in several counties including Dunn. The course had over 300 statewide participants. Part of my work with this committee included serving as a

lab instructor and coordinating the newly added Q & A sessions that involved interactive sessions with 13 Extension specialists on topics of soils, insects, plant disease, wildlife, weeds, container growing, fruit, vegetables and lawns.

I participated on a State Horticulture Committee to plan a statewide webinar series for consumer horticulture audiences where participants learn about horticultural best practices and how they can play an important role in addressing identified environmental issues in Wisconsin.

I initiated a new youth gardening program with the Boys and Girls Club at River Heights Elementary school. Youth gardens provide opportunity for hands-on learning that promotes best practices in the garden, connects kids to the natural world and encourages lifelong healthy eating habits.

Dunn County Master Gardener Volunteers also support identified Horticulture Program outcomes. Volunteers answer garden questions, educate the public, and participate in numerous garden projects that teach best horticultural practices, aid local food security efforts and provide personal and community well-being.

To support volunteer development, in 2021, we piloted a Master Gardener Mentorship Program. The overall goal of the program was to help acclimate new volunteers to their local Master Gardener Program and, ultimately, increase volunteer retention. I reviewed feedback from the mentees and found that 86% stated that the mentorship had helped them become better familiar with their local Master Gardener Program and helped facilitate their involvement in volunteer service. In general, mentees described the program as successful because it provided hands on learning opportunities, support to get started volunteering and occasion to learn from an experienced gardener. The results were very positive and supported our program objective. Successful mentoring programs have been shown to increase volunteer retention. Human Development & Relationships



Stephanie Hintz Human Development and Relationships Educator



Stephanie's efforts to *increase social and emotional wellbeing for all youth and families in Dunn County* is grounded in local community needs assessments and backed by state and national research. Her efforts can be categorized into three main strategies to address the local and emerging needs of the community including (1) expanding access initiatives, (2) parenting programming, and (3) mental wellness initiatives.

Expanding Access Initiatives

Dunn County's demographics are becoming more diverse. In the wake of emerging state trends and embracing diversity, one strategy is to build and maintain relationships with the Hmong and Hispanic/Latina/o communities and agencies who serve this public in Dunn County. Building relationships and promoting equitable access to educational opportunities for historically underrepresented, disadvantaged, and/or underserved populations will be a first crucial step to cultivate an inclusive and welcoming environment in our community. The intention is to build strong connections that allows historically underserved populations feel more comfortable to attend relevant and social emotional wellbeing programming.

Specific efforts include but are not limited to:

- Hmong Friendship Center. There are over 30 Hmong Elders that participate in the program and with the 503c3 status they hope to grow to include intergenerational programming in the future.
- Creating an Anti-racist Statement. This effort started at the county level but then was pushed to the state level. Statement will be vetted and shared in 2021.
- A Fair and Just Recovery Grant. Awarded for the project to support colleagues across institutes to facilitate conversations that support a fair and just recovery in communities. These conversations and subsequent actions will focus on centering the voices of those most impacted to build awareness and take action towards addressing social and economic inequalities.

Parenting Programming

Research indicates the primary protective factor in helping children heal from ACEs (Adverse Childhood Experiences) or counter effect ACEs is the presence of a consistent, supportive, and loving adult. Parental knowledge of child development and parenting skills are pinnacle to foster healthy relationships with children.

Specific efforts include but are not limited to:

- Parents Forever. A research-based parenting curriculum developed by the University of Minnesota - Extension and Dunn County court-ordered divorce parenting programming. Held 12 times, supported 52 parents. 100% of participants reported gaining valuable information for their life.
- Parenting with Love and Logic Classes. An evidence-based approach designed to create positive schools and home culture. Held once before the pandemic shut down programming and the curriculum creators did not approve of online presentations until later in the year.
- Trained in Triple P. An internationally recognized and accredited evidence-based parenting curriculum developed by the University of Queensland in Australia. Training completed in level 2 (a series of parenting seminars) and level 3 (a series of group discussions).



Mental Wellness Initiatives

According to the Dunn County Community Health Needs Assessment Report in 2019, Mental Health was listed as the number one priority in the realm of health that needed improvement in our community.

Specific efforts include but are not limited to:

- **Providing WeCOPE programming.** Created and launched a healthy coping mechanisms curriculum, starting 2021.
- Health Dunn Right Mental Health and Wellness Action Team. Provided several free mindfulness and self care series.

- Created and launched Practicing the Pause. A weekly, 30minute virtual space to practice a variety of techniques to calm your mind and body, decrease stress, and increase selfawareness and resiliency. We practice holding space while also practicing skills such as deep breathing, guided imagery, gentle stretching, etc.

Wisconsin 4-H

4-H empowers youth in grades K-13 to reach their full potential while learning citizenship, leadership, and life skills. For over 100 years, Dunn County has been a leader in 4-H youth development. Members learn by doing; through projects, activities, and adult mentorship provided by dozens of trained and background-checked volunteers.

Long term studies show that those who participate in 4-H are **4 times more likely to give back** to their communities, and **2 times more likely to make healthy choices**. That means that **investing in 4-H makes good sense** in both the short term and the long term for our community.

In 2021, Dunn County had 13 community clubs and 6 chartered project clubs **serving close to 300 4-H youth and 74 adult volunteers**. This year has been a year of re-building after pandemic restrictions brought many of our favorite 4-H activities to a complete halt.

Locally, the lack of broadband internet meant that the pivot we made to offer more virtual 4-H programming was not available to all 4-H families.

Livestock Premises Identification

• Wisconsin Act 229, 95.36 UW-Extension serves as a local partner with the Wisconsin Livestock Identification Consortium assisting livestock owners' complete the appropriate paperwork to comply with Wisconsin Livestock Premises Identification requirements.

Beef and Pork Quality Assurance and Youth for the Quality Care of Animals

• This is a National Beef and Pork Board administrative rule that states that producers and youth must complete training and become certified to be able to market their livestock. Extension is one of the primary trainers for BQA, PQA, and YQCA and can sign certification cards indicating that the training has been completed.

Emergency Government

• Homeland Security Presidential Directive -5. Establishment of NIMS. Extension is one of numerous county partners trained to perform duties as part of the Dunn County Disaster Assessment Team.

Farm Worker Safety Education

OSHA directive CPL 04-00 (LEP 009) for Wisconsin Dairy Farms, was established in late 2011. It requires dairy
farms with over 11 employees to provide safety training to their workers. Extension provides this training for
skid loader safety and cattle handling to meet this mandate placed on local dairy producers as well as providing
walk through and check list reviews.

Youth Protection Program

• 4-H Adult Volunteers must complete the Youth Protection Program to serve in leadership roles in 4-H Clubs. This includes background checks, volunteer orientation training, and mandated reporter training.

Human Development & Relationships Mandated Programs

Parents Forever

Dunn County Courts require divorcing parents to take Parents Forever per State Statute 767.401: During the
pendency of a divorce or paternity action, the court may order the parties to attend a class that is approved by
the court and that addresses such issues as child development, family dynamics, how parental separation affects
a child's development, and what parents can do to make raising a child in a separated situation less stressful for
the child.

Federally Funded Nutrition Education Programs

FoodWIse

 Title III of the Older American Act funds meals and address food insecurities. State Policy and Procedure Manual of the Wisconsin Aging Network, Chapter 8–8.4.4 states Nutrition Education will be provided a minimum of four times per year (one time per quarter) to participants in congregate and home delivered meal programs. Where feasible, each program will provide monthly nutrition education suitable to participant needs and interest.

Food Share Employment Training Program

• This is a federal requirement that can help some FoodShare members meet the work requirements in order to continue receiving FoodShare benefits.
